1. This is an agreement between NAIT and the above individual for the rental of one: bike locker, E-Compound access or underground bike rack access for personal bike use only.
2. This agreement is valid for the individual, location and the dates noted above, unless otherwise terminated by NAIT Parking Services. You shall not assign, sell, or transfer the bicycle rental and shall not grant any licenses or other rights to others to use the bicycle rental.
3. This agreement will automatically terminate at the end of the rental term noted on this form unless the renter renews the term within five (5) working days prior to the rental termination date. Any items left after the rental term, will be discarded.
4. NAIT reserves the right to change the rental fee from time-to-time by providing advance notice by posting on the NAIT website at least 10 days prior to the effective date of fee increase.
5. In the event the key is lost for the bike locker or E- Compound **or not returned within 5 days of the end of the rental term**, the deposit will be forfeited.
6. The use of the bike locker, E-compound, and/or bike rack is at your own risk. NAIT is not responsible for any injury, loss or damage to you or your bicycle or its contents. Any bicycle parked, operated, or driven on campus shall be solely at the risk of the owner and driver. NAIT shall not be liable for any damage to the bicycle or driver thereof or any other person unless such damage has resulted from the negligence of NAIT’s employees or its agents in performing their duties.
7. The renter using the bike storage in E are responsible for ensuring that the gate is secure when they are leaving and their bicycle is secured to the bike rack.
8. Any issues with using the bike locker, E-compound or the underground bike racks, such as lost key, vandalism, or lock/door not opening and closing, must be immediately reported. Call Parking Services 780.378.6989
9. NAIT reserves the right to open and inspect all bike storage periodically. Any items that are not reasonably connected to the use of a bicycle will be removed.
10. Any breach of the above terms shall result in termination of the agreement.
